In the unlikely event that William Sanders fails to provide an agreed upon service(s), Customer agrees to release William Sanders of all claims and demands and William Sanders agrees to return any payment(s) received for that service(s). Under no circumstance will William Sanders be liable for any amount in excess of payment(s) made by Customer and received by William Sanders. William Sanders shall in NO event be liable for incidental or consequential damages.

William Sanders reserves the right to use the original tape and/or reproductions for display, publication, advertisement and all other purposes. William Sanders retains the copyright of all work(s). No copies or reproductions can be made, without William Sanders' expressed and written permission.

If date(s), time(s) and/or place(s) are changed and William Sanders is unable to accommodate all changes, Customer agrees to forfeit all payments made and release William Sanders of all claims and demands. In the event of Customer's cancellation, Customer agrees to forfeit all payments made and release William Sanders of all claims and demands.

**Additional Charges.** Additional charges may apply for event locations outside Hamilton County, Tennessee. If the event(s) exceeds the time(s) stated on the price sheet by starting late and/or running long, additional charge may apply. Reception time starts at Bride's arrival and no later than one hour after the end of the ceremony. More additional charges may incur for special request, changes and/or anything not ordinary and/or anticipated.

William Sanders shall include all employees, independent contractors, agents, and persons assisting William Sanders. "Pre-Ceremony" is taped at the ceremony's location the two hours before the scheduled Ceremony. "Pre-Reception" is shot upon camera operator's arrival at the reception after the ceremony. The number of guests interviews will be limited and will vary due to time and/or circumstances. Final video length is reduced in editing for artistic, technical and economic reasons. William Sanders may decline to use photos or music with possible copyright issues. Customer agrees to hold harmless, indemnify and defend William Sanders from all claims by third parties related to privacy, trademark, and copyright issues.
